Wheeler Mission is a non-denominational, Christian organization that provides Christ-centered programs and services for the homeless and those in need, with the vision to see every man, woman, and child serviced, equipped to be productive citizens who enjoy lasting success in Christ.

Ministry and shelter to the homeless. The Mission provides temporary emergency shelter to homeless and/or disadvantaged men. Breakfast, lunch, dinner, showers, clothing, chapel services, case management (with referrals to onsite and offsite social service agencies) are provided. Medical, dental, and podiatric services are also available at on-site clinics. As well, Wheeler provides programs for guests who are employed but have no permanent residence and guests with physical and mental challenges. Wheeler also provides shelter as part of the City of Indianapolis' winter contingency plan for the homeless during inclement weather.

4b (Code:) (Expenses \$ 1,136,968 including grants of \$ 17,800) (Revenue \$ 338,744)
Drug and alcohol rehabilitation program. The Hebron program with facilities in Indianapolis and Bloomington address addictions which often press men into homelessness. It is not unusual for men to arrive at the Mission owning only the clothes on their back. For those who desire to enter a recovery program, they begin by working through a two week pre-entry trial period to see if they are ready to commit to a year-long residential program. Men must follow a strict regimen and adhere to all rules before they can move on to the Orientation Phase. Once this phase is complete, men move to the Hebron Center in Bloomington for the duration of the program. This 288 acre facility provides class time, homework, peer groups, and work assignments at the onsite wood mill, grounds keeping, or kitchen duty among others. This program is known for its tough love approach where the staff model integrity, problem solving techniques, training in marriage and parenting. Men are held to high standards of accountability. Families of the men may visit on weekends to attend family counseling sessions offered by trained counselors.

4c (Code:) (Expenses \$ 1,046,191 including grants of \$ 2,550) (Revenue \$ 2,370)
Women's shelter program. The Center for Women and Children was created after renovating the community center and moving the Care Center's program to the renovated facility. The Center provides an environment that is safe physically, emotionally and spiritually for women and their children. Hundreds of women and mothers with children enter our doors seeking food, clothing, and housing. These women find these vital needs supplied, but they also experience love and compassion, bringing rest for their weary souls. National studies indicate that the fastest growing segment of the homeless population consists of women and mothers with children, making these services offered at the CWC imperative to our community. The average stay at the Center is 28 days. During that visit, ladies are given counseling, job readiness training, assistance in job procurement, education assessment and tutoring, medical services, addiction counseling and encouragement to enter one of our long term residential programs.
